- Payment must be made in full two weeks before your first market.
- There will be NO refunds for dissatisfaction of sales or booth location, change of mind, no-show or inclement weather.
- Vendors must abide by the market's rules and regulations as well as those of the Lodi Police and Fire Departments, State Board of Equalization and Health Department.

## VENDOR RESPONSIBLE:

- Reading, understanding and following all Lodi Farmers Market Rules and Regulations. These rules and regulations are available online at [www.lodichamber.com](http://www.lodichamber.com) or at the Chamber office.
- Assembling and staffing own booth
- Purchasing/supplying all food, materials and equipment necessary to properly and safely run the booth.
- Comply with all Police and Fire Department Rules and Regulations (Fire Department: 209-333-6735)
- Collection and handling of money for their business
- Booth display sign(s)
- Adhering to Environmental Health Department Regulations
- Cleaning your area after the event. Leaving no trash. Space MUST be left as found.
- No selling outside of your space is allowed.
- Complete and sign the mandatory Liability Clause below. Return original signed copy with Application. Keep a copy of all paperwork for your records.
- You may not serve beverages or additional food other than what is listed and approved.
- Food vendors must provide a copy of their certificate of liability in the amount of \$1/\$2 million naming the Lodi Chamber as additional insured.

- **Completed and signed 2026 Farmers Market Application**
- **Liability Insurance must be enclosed with this Application**
- **San Joaquin County Temporary Food Vendor's Application**
- **A copy of a valid seller's permit**
- **Payment in full with application**

- San Joaquin County Temporary Health Event Permit
- Advertising
- Sending vendor space assignment

## IMPORTANT DETAILS:

**RAINOUT POLICY:** The Market will take place RAIN or SHINE or HEAT. There are NO rainout refunds!

**FULL attendance** is necessary, if miss more than 2 weeks, you will be dropped from season

**NO REFUNDS .**

WE DO NOT promise exclusivity but will use common sense in assigning spaces.

Submitting this application is not guaranteed acceptance of your space in the market. Past participants will be given priority consideration if complete application and payment is submitted on or before the above date.
