- Admittance into the Farmers Market is at the sole discretion of the Lodi District Chamber of Commerce. If not accepted into the Market, payment will be refunded in full.
- Payment must be made in full two weeks before your first market.
- There will be NO refunds for dissatisfaction of sales or booth location, change of mind, no-show or inclement weather.
- Vendors must abide by the market's rules and regulations as well as those of the Lodi Police and Fire Departments, State Board of Equalization and Health Department.

## VENDOR RESPONSIBLE:

- Reading, understanding and following all Lodi Farmers Market Rules and Regulations. These rules and regulations are available online at [www.lodichamber.com](http://www.lodichamber.com) or at the Chamber office.
- Assembling and staffing own booth
- Purchasing/supplying all materials and equipment necessary to properly and safely run the booth.
- Comply with all Police and Fire Department Rules and Regulations (Fire Department: 209-333-6735)
- Collection and handling of money for their business
- Booth display sign(s)
- Adhering to California State Board of Equalization regulations
- Cleaning your area after the event. Leaving no trash. Space MUST be left as found.
- No selling outside of your space is allowed.
- Complete and sign the mandatory Liability Clause below. Return original signed copy with Application. Keep a copy of all paperwork for your records.
- You will be given a 10' x 10' space for your booth. Please ensure that when you occupy your designated space, you do not encroach into adjacent areas or impede on other spaces with your vehicle. If additional space is needed, you will need to purchase another space.
- You may not sell any items not listed and approved by the Lodi District Chamber of Commerce

## REQUIRED DOCUMENTATION:

- **Completed and signed 2024 Farmers Market Application**
- **Liability Insurance must be enclosed with this application**
- **San Joaquin County Temporary Food Vendor's Application** (*for any pre-packaged food*)
- **A copy of a valid seller's permit**
- **Payment in full with application**

RAINOUT POLICY: The Market will take place RAIN or SHINE. There are NO rainout refunds!

NO REFUNDS after April 16th, 2024 There will be a \$35.00 charge on all returned checks.

WE DO NOT promise exclusivity but will use common sense in assigning spaces.

Submitting this application is not guaranteed acceptance of your space in the market. Past participants will be given priority consideration if complete application and payment is submitted on or before the above date.
